

Instructions to the foreign applicants who seek registration for Postgraduate courses at

POSTGRADUATE INSTITUTE OF PALI AND BUDDHIST STUDIES, UNIVERSITY OF KELANIYA, SRI LANKA.

- All the applicants should buy the application available at a cost of Rs. 500 (MA/PG Diploma) and Rs. 1000 (research degrees) at the Institute or may use the temporary registration form in the web www.kln.ac.lk/institutes/pgipbs
(Email: pgipbs@gmail.com or pgipbs@sltnet.lk)
- Duly filled application should be submitted to the Institute along with **copies of relevant certificates** and **a copy of passport**.
- The Institute will then scrutinize your educational and other documents and selection will be informed to the Department of Immigration and Emigration, through the Ministry of Higher Education.

The following procedure will be carried out by the Department of Immigration and Emigration for the purpose of issuing visa.

ISSUE OF VISAS TO FOREIGN STUDENTS

Please note that Electronic Travel Authorization (ETA) or on arrival visa will not be converted in to a Residence Visa by the Department of Immigration and Emigration in Sri Lanka.

Entry Visa (EV) and Residence Visa (RV) Procedures for Educational Purposes

The following documents will be submitted to the Department of Immigration and Emigration by the POSTGRADUATE INSTITUTE OF PALI AND BUDDHIST STUDIES.

1. Request letter from the PGIPBS
2. Recommendation letter of Ministry of Higher Education
3. Copy of the applicant's passport

On receipt of the above documents and if they are found to be in order, necessary instructions will be issued by Department of Immigration and Emigration to respective Sri Lanka Overseas Mission (High Commissioner or Embassy in your country) to issue an entry Visa. (Payment of an administrative fee of Rs. 750/= to the Department of Immigration and Emigration is required.) The applicant should then personally visit the respective Sri Lanka Overseas Mission (High Commissioner or Embassy in your country) and obtain the endorsement of EV in your passport.

Once you arrive Sri Lanka, the proper registration must be obtained for your selected course of study at PGIPBS. Then the PGIPBS will issue the residence visa (RV) documents.
